Reform is also needed on a lower plane especially with regard to the admittance of non-students into the Union Building. The recent trend of violence to the porters and students by complete outsiders has become alarming and must be stopped. This can't go on uncontrolled especially on Saturdays of nights when there are bar extensions, where the presence of these trouble makers, e.g. Hell's Angls. cause a lot of disruption. For the safety of our visitors, guests, other Union cardholders, Union staff and ourselves, I thoroughly welcome the introduction of card checks at week-ends.

To carry the idea of personal safety further, the proposal of a Union bank has great potential. Not only would it be a much needed service for student members (e.g. society treasurers) but it would also facilitate greater protection for Union staff involved daily, with the transportation and handling of considerable amounts of money.

Finally we must endeavour to allocate money in a responsible manner, not only in taking into account the vast diversity of interests found within a community of 10,000 students, but also the fact that the Union faces serious financial difficulties.



In the last five years - three spent on Union Council and two as Secretary - I have worked efficiently and have involved myself with every aspect of student life. I have followed ALL Union mandates and instructions, and I hope that my vast experience in Union, University and National affairs will give me the opportunity to serve you well as President, and involve more students at every stage of decision making. I have become exceedingly concerned with the gradual decline in participation in the Union. The Executive has become isolated from the majority of the membership, and many students now find Union affairs irrelevant. What is needed is a change of direction and a change of attitude. This is why I proposed the increase in Sabbaticals last year, and this year returned to the A.G.M. with the two tier system. The two Executive field officers in this system will do more to build up interest and participation within the student community. Executive officers must realise that their responsibilities lie outside the shell of the building, and must therefore be available in all parts of the campus and to all sections of our 10,000 strong membership.



year to cater for Post-Graduates, Overseas Students, and those who remain in Leeds during Vacs.

EDUCATION .-- I believe that the Union should play a vital role in the redetermination of the whole position of examinations, course content and teaching methods Close links should be maintained with Staff/Student Committees and S.R.C.s, and the wealth of information which the Union possesses should be used to help the mass of our membership to a greater understanding of the issues involved.

WELFARE .- We have all tried and failed to encompass the members' growing welfare needs and we now require a full-time Welfare Officer. In Accommodation, the Union and the University (with their vast resources) must buy up property for cheap letting. The University should also price their premises according to square footage, services, and distance from the campus. Production of full information sheets and booklets, as well as the personal representation which I have conducted at tribunals must be increased and encouraged.

NATIONALLY .- We must use all available means, including the N.U.S., to press our claim to a fair grant (linked to a student cost index), oppose loans, gain meaningful representation, better facilities, reduce Overseas Students' fees, and oppose the proposed exclusion of students from Rent Rebates and Tax Credits.

INFORMATION .- The biggest problem with this place is the appalling lack of information and the poor accountability of officers. I promise to increase both the quality and quantity of information disseminated within the University. Members must know everything that their Executive is doing, and be aware of all the issues involved. I hope to expand the information sheet as I expanded the Union Handbook in order to enable all members to participate fully at meetings or in the U.C. referendum which I have introduced.

President, Swansea University Union (1971/72).

We are all experiencing a sustained Government attack on our living conditions and standard of education. The real value of our grants is declining and many of us are forced to live in bad accommodation and forced to accept cuts in our standard of living. The recent Government White Paper on Education threatens through such measures as the worsening of staff-student ratios to cause a deterioration in the standard of our education. This is occuring not because the Government are misguided but because they are attempting to make British capitalism more competitive in the world market at the expense of the majority of those they claim to represent.

To resist this attack and launch a counteroffensive we clearly need a strong union. But Leeds University Union is no more than a srell; few students know or care what it does because they do not see its relevance to the problems they face. The main priority of next year's President must be to actively involve the student members in the running of their union.

We need a strong union with fighting socialist policies.

1) **GRANTS.** It is vital that LUU actively participate in the National Grants Campaign. The decision against a rent strike lost term was a disaster which has isolated us from virtually every other University



Union. The question must be raised again as must the question of a catering boycott If NUS loses this fight then it will leave the door wide open for the Government to cut costs by introducing loans or ensuring that more students live at home.

2) **STUDENT-WORKER SOLIDARITY.** The attacks of the Government are not directed against students alone. If we are to break through the "freeze" then we must unite with those workers who are fighting back. Specifically we must aid campus workers in their struggle for better pay, hours and conditions.

- 3) UNION AUTONOMY must be defended against attacks from either Government or the University authorities and must be extended to remove the ultra vires restraint on our financial autonomy.
- 4) DEGREE FACTORY. The role of the University in processing students to fit into their alloted slots in the labour market should be challenged. This involves criticism of course content and opposition to assessment.

This manifesto deals with the political role of the President within the Union, (I have been Sabbatical President of Swansea University Union and have the administrative competance to do the job). I am a revolutionary socialist and a member of the International Socialists and challenge other candidates to openly state their politics and recognise the political nature of this campaign.



The prestige of the Union is undoubledly at an all time low. The majority of the Union members have shown strongly on a number of issues that they no longer trust the Union, its policies or its officials. The blame for this undesirable state of affairs must be laid squarely at the door of the Union bureaucracy. To apportion blame is not enough. This disturbing situation with which the overwhelming majority of us are dissatisfied must be remedied.

EXTERNALLY, what is unfortunately happening at the present is that a faceless minority dictates to us what we ought to think and what our policies ought to be. This has to stop. Our Union must, and I hope will become, the vehicle of our members; the policies of our Union must reflect the wishes and desires of our members. Only when this happens can the President be an influential representative of the Union and consequently more weight will be added to our case when presented by him externally.

With the increasing growth of the University in numbers and area, the general atmosphere is becoming too impersonal. In the face of this trend the Union must ensure that its own bureaucracy, does not become so dominant that students requiring urgent help or assistance in vital fields such as accommodation and welfare feel that the Union also is no more

than an impersonal machine. This must be avoided at all costs.

Furthermore, the Union is not just the Union building. The President must never forget that Engineers, Medics, Dentists and people living in Halls of Residence and Flat Units, although some distance from the Union building, are an integral part of the Union and must therefore be represented. It is shameful that far too often these members are only considered when the Union collects their fees! The Union officials should stop abusing their authority by merely issuing written directives to these bodies. Instead they should step up efficient, and of prime importance, personal channels of communications to facilitate a genuine exchange of ideas and information.

The Union offers a wide range of services for its members. For these services to be continually improved and expanded, it is necessary for the Union to be in a healthy financial position. Obviously there is never enough money to satisfy everyone's needs. In the last year as Treasurer, I was faced with the problem of Union Sports Clubs and Societies struggling to make ends meet because the Union was not in a position to give them as much money as they required.

This situation will get worse unless a recent Union Council decision is reversed. This decision was to create a machinery to divert funds away from Clubs and Socie.ies and all other Services and channel them into a separate account from which donations to outside Political bodies can be made. I strongly oppose this decision and I specifically ask you to give me a mandate to reverse this insane decision.

In conclusion, I assert that this Union is capable of being more useful to its members and a better Union for all of us. It will not become so by fancy constitutional changes, but only through a change in attitude of Union officials including the President.
