Although the direct power of the Union is small (through sit-ins, etc.), the student response to the Thatcher proposals has proved that we do have political power when united in action. We must recognise this fact and utilise it. We must also recognise that the attacks being made on student conditions to day, through the refusal to give a decent grant increase and through legislation such as the Housing Finance Act, are being made by the Tery Government. The Union cannot afford to be neutral in the battles being fought in Britain today. We must come down clearly on the side of trade unionists, tenants and others who are fighting back against repressive Tory policies. I will attempt to commit the Union to use its facilities to actively support those in struggle. Finally, politically, we have no choice as yet but to stand for the return of a Labour Government and to demand that it repeals anti-union laws, restores welfare cuts, ends unemployment, repeals racist immigration laws, and guarantees full autonomy to all student unions. It is only by allying ourselves politically with those in the labour movement who positively respond to the Tory attacks that we can begin to solve the major problems that we face as students.

I want to carry on the work already started to establish a book shop in the Union itself. Not just a paperback shop which we have at present, but a shop selling textbooks where we can provide a better service than Austicks, who are already trying to put pressure on the publishers not to supply us with books, as they know that they have cornered the market on a good proportion of every student grant. We should be able to acquire our own books and plough back the profits we would have to make, due to fixed prices, straight back into the bookshop, rather than into the pocket of private enterprise. When internal strife rages, or threats from outside become too manifest to ignore, it is fundamentally essential that students of all wings, unite to face a common enemy.

As a post-graduate student from another University, I am not new to student politics. At my first University I had a lot of experience of committee work -- from Action Committees on the student accommodation question to a department committee which I ran for two years. During my three years I became involved in the struggle to get more representation for students; a question which became critical when the University's charter came under review and the student body was presented with a series of propositions that could only be seen as reactionary and patriarchal in outlook, and would have virtually ended the power of the student's Union in any real sense, and this sometime before Mrs. Thatcher's hatchet proposals. We managed to defeat the College Council on most of the issues and all the important ones: the most militant action being a sit-in, which I helped to organise, and which had never before been known in the small Welsh town of Lampeter.

It was with action like this and valuable experience in being first secretary and then President of Socialist Society, that I had my introduction to student politics. I am new to Leeds and to the set-up of the Council structure here, but I am well acquainted with the ordeals of Council work. This has taught me many things — one is to truly represent the people who elect me: I believe in following mandates and not my own personal whims. Another is that representation is vital to any student body if we are truly to share in the organisation within the University. So, too, is the question of Union autonomy and I feel it will be my duty not only to resist attempts to limit this, but also to strengthen and extend it.

My main concern are those which concern the standard of a students living allowance. I see the struggle for a grant's increase as vital, especially as rising prices and the prospect of Value Added Tax, make the prospects under the present grant rate grim. Involved in this must be the active campaign to resist the Housing Finance Act — which will only further increase the decline in living standards, and this problem of student accommodation cannot be seen except in relation to the general housing shortage and attacks on the public in general. There is also the question of catering with which most of us are disattisfied — and I believe that subsidies from the U.G.C. are the only real answer to this. Lastly I feel that the recent rise of racialism, and the racialist campaigns within our society must be actively combated. Thus attacks against students cannot any longer be seen in isolation — they are part and parcel of the policy which attacks all stratas of society, and student politics are becoming more and more involved in the politics of the larger community.

If you want a Union Council which will fight on all these issues and involve you in the campaign and decision making — vote for me
