My primary reason for standing for Union Council is to fight for issues which affect the position of women in education. Although the union has policy condemning the objectification of women this policy is by no means comprehensive and action on issues affecting women are largely ignored in the campaigning activities of the union.

The discrimination against women in society stems from the common attitude which still sees women's role primarily as the breeding and rearing of children, and this is reflected in the education system. Content of courses, especially in the arts and social scienes, ignores the role played by women. For example, a history course which constantly refers to 'Great men of history' alienates women and perpetuates the myth of their non-participation in society; also it is important to realise that the lack of famous women artists is not due to an innate lack of artistic qualities but to the social conditions in which they live.

The reduced grant for married women, the absence of a Family Planning Clinic and the disgracefully undersized nursery all reflect the attitude of society that women are the secondary sex in education and employment. All these issues are of the greatest importanec if women are to have equality of opportunity in society, an end which is vital to a democratic

education system. Passing motions in O.G.M.'s is far from suficient, so too are policies merely preventing such events as beauty contests and slave-girl auctions.

These must be accompanied by discussion of the issues in the union and vigourous campaigning to alter attitudes and conditions. Government cuts in education finance are a threat to the women in further education of all types and these must be opposed through student action. Why should cuts in education even be considered while such huge sums are wasted annually on military expenditure, the Chunnel, the 3rd Airport etc. Education facilities must be extended, attitudes to education must be questioned and the content of courses must be changed.

As a socialist, and as a woman, I think that the only way to safeguard and improve the quality of life is to raise people's conciousness of discrinatory forces in society.

On Union Council I will argue with a socialist perspecivte and fight for equality of opportunity for women in education.

UNION COUNCIL is the most powerful elected body in the union. The executive is responsible to it. Both U.C. and exec however are responsible to ordinary general meetings (O.G.M.'s). You or L or any other student can attend once a week and support, amend or reject a motion on anything put forward by exec, u.c. or any other ordinary member.

Anyone elected to any post or committee is subject to recall by ordinary members. This, of course, will include all candidates elected in this ballot . . THAT'S DEMOCRACY.

I realise this is long-winded but I feel it's important to point out why the accusation from the Right-wing that the union is undemocratic is a fallacy (to put it politely). The union ,by its democratic structre (and this applies to all democratic institutions) will only reflect the views of those who take an active part in it. If you don't take part; you've no right to criticise the actions of those who do.

I believe that the unions main concern should be for the welfare of students. This includes accommodation, financial help and so on as well as recreational facilities e.g. bars, discos, societies etc. But the main concern at the moment should be to get a reasonable level of grant for ALL

Even the lucky student with a full grant of £605 with inflation running at $20\,\rm C_L$ isnt exactly rolling in cash. As for students on discretionary awards, or whose parents wont pay their contribution, or those with no grant at all; how do you think they manage? If you don't care then we might as well not have a "union" but have a social club instead. We have a just case for an increase but like all other groups in our society if you can't fight (or WONT fight) you wont get it. I think the course to take is quite obvious: well have to back our case with action.

EDUCATION (thats why were here) is a right and not a privilege. The "cuts" (£180,000,000) will bite deeper as inflation rampages on. Two colleges (london, northumberland) will bec losed next year. Leeds univ won't close but academic standards will deteriorate as time goes on; postgrads, cleaning staff, lab demonstrators and even professors - there will be less of all of them around. Is that what you want?

I have sensed a great deal of alienation between students and the Constitutionally-elected Union body. Partipating is at a minimum at both political and social levels. The obstacle to greater and more active participation in Union affairs stems from the complete bureaucratisation of the Union which effectively cuts vital links with the students it represents. Government of the Union must come flom the students themselves. It is all very well for the Union bureaucracy to encourage us to participate but, until that bureaucracy is cut down to a more personal level, there will be no progressive participation by the students in Union affairs.

I am not actively involved in any political associations within the Union, yet it would be deliberately misleading you if I were to conceal my socialists beliefs. However, I am not a hard-liner and would be open to present suggestions that you offer to me. That is what participation is all about! That is how links are forged between you and the Union

I am in favour of increased grants on the basis of present rampant inflation which is effectively cutting our purchasing power week by week; of the abolition of the means test for students which leads to inequalities of grants; of the education cuts because education is a right for all and opportunities should be extended, not limited; and I am against the discrimination by the grants system concerning married women and over-

The Union has, thus, two responsibilities. It should act in the interests of its members and thus organise its internal administration along more personal lines and so head criticisms against the existing system as well as being involved in movements outside the University and so giving students the opportunity to express their views, even though they are not direct concerns of University internal life. But one responsibility should not predominate against the other.

THE UNION should be both a social centre for it's members and an organisation for aiding students and campaigning in their interests. At present it is not performing either of these tasks effectively.

THE UNION BUILDING is in an appalling state and improvements must be made. These will be costly, but are-I feel- essential. I am in favour of consultations with students to see exactly what they want from the building before changes are made.

CASH is in short supply. The Union must press the University for an increase in the Union fees. A substantial increase is necessary due to the effects of inflation and the need for improvements in the Union build-

GRANTS & EDUCATION CUTS are matters of great importance to students, I support the N.U.S. campaign on these issues — including the demand for an £845 grant — and believe that we should make a more active contribution towards it.

INVOLVEMENT by students in the affairs of the Union must be encouraged. However, students will not become interested in the Union unless it is seen to be actively campaigning in their interests. Grants and education cuts are not the only issues on which more work is needs to be done. Accommodation, welfare, and education - course content and structure, methods of assessment etc. — are all areas of importance to students in which the Union should be more active.

MEDICAL STUDENTS often feel that they are being neglected by the Union, I shall support attempts to set up a working party - consisting of representatives of U.C. and the medics - to look into these grievances and recommend solutions. Also, we must ensure that when the Lipman Building is demolished it is not replaced by an inferior structure.

If elected I shall vote in accordance with the principles that make me a supporter of the Broad Left in student politics and a member of the Labour Party. Those candidates who describe themselves as "moderates" are often supporters of the Tory Party - but apparently ashamed to admit it. Don't let them get away with this abuse of the English language. Unquestionably next years Union Council will be faced with even greater financial problems than are appartn at the moment. The cuts in social expenditure (already responsible for the cancellation of the LGI building project) will have precipitated a crisis situation in education - reducing student living standards and academic standards. In the Union the drop in financial reserves resulting from the inadequate per capita payments made by LEAs precludes any sizeable improvements in the amenities of the union building - an issue that is naturally causing concern among union members. Hence no prospective member of Union Council can avoid the present political climate. To fight this situation there is need for a forceful leadership. The Broad Left domination of NUS has created a feeling of fatalism and demoralisation in the student movement. By failing to lead the struggles of last term, the NUS leadership has allowed the retrograde forces of the right to go on the offensive. Thus the most pressing issue is to unite the anti-Broad Left militants by an injection of new vitality into student politics on the following issues:

A cessation of all cutbacks in the quality of education coupled with a grant increase to £900 (the magical figure of £845 having already been outdated by inflation) protected by a sliding scale coupled to prices. Students should not be forced to pay for an economic crisis which is not

2) NO PLATFORM FOR FASCISTS AND RASCISTS

Total opposition in the University to the doctrines of racism and discrimination against overseas students in the matter of fees etc. 3) WOMENS RIGHTS

For adequate nursery facilities, an end to discrimination against married women in the grants system and autonomy for womens groups.

An objective solution of the emotive Irish question incorporating an immediate withdrawal of British troops and self-determination for the Irish

A principled opposition to involvement in the EEC has to be formulated. We must reject the chauvinist objections of the GBOC with the likes of Powell and build a distinct campaign characterised by a socialist analysis of the nature of the EEC. The EEC represents a final attempt by British capitalism to rejuvinate itself. Opposition should derive from a belief in the creation of the United Socialist States of Europe.

The standard answer to such problems seems to be the re-carpeting of the extensions, but important as this is it is hardly a complete answer. The lack of interest in the Union suggests that students find identifying with it difficult, which is not surprising as there is, in reality, very little to identify with. The Union could do far more, in terms of practical help, for students - in their relationship with the University, in housing, in legal and financial aid, in pressurising L.E.A.'s to get grants out on time, and in contacts with the City, as well as it's present campains. Greater activity in such areas would make issues of policy and finance of far more relevance to the ordinary member, and I would press for improve-

Our entertainments policy also needs a rethink. Ents, is fine at putting on big gigs, but surely the Union should offer some alternative to paying £1 or so to see the current "Big Name". In Ents, and Arts Fest. I have supported the inclusion of cheaper and more varied events, with results showing in the "Rockspots" I have put on for Arts Fest. over the last two terms and in the M.J. This means a SLIDING SCALE of gant tied to a student cost of living index with a NIL-NORM THRESHOLD i.e. if prices go up 20% the grant goes up 20%. I call myself socialist, but am often called communist - among other things) I am not a member of any Political Society, but that is because of other commitments rather than any opposition to them.

This year has seen a positive decline in the Union, in terms of the Union as a building and as a body fighting for students' needs. The recent victories of 'moderate' candidates must be seen as part of a swing to apathy rather than mederation

The Union as a building will not be improved by cutting services which some people propose as a means of balencing the Union's books. The solution must be in improving services to bring people back-and hence increase income. Also the University gets more money in by charging higher fees for overseas students.

Last year grant increases may have seemed a lot but its value has clearly been eroded and the grant system still has many inequalities eg. over married students, parental contributions, discretionery awards etc.

Housing may be an important issue with the possibility of action like that in Nottingham with a landlord's ban on students because they go to rent tribunals to get fair rents. The University will also be trying to increase hall and flat fees.

These and other issues such as the NUS campaigns on women and gays must be taken up by the Union with an active leadership from Union officials if the Union is to mean more than the shell of a building.

In recent years one of the major functions of LUU appears to have been ignored, ie, that of working to improve the quality of education at Leeds. By this time in the session many students who came to Leeds expecting stimulating and relevant courses have become dissillusioned. They find many of their courses irrelevant, badly structured and often boring. Many accept this as being an inherent part of Higher Education. I DON'1. There are a few courses which must have a rigid structure - eg Medicine however most courses could be much more flexible. The present assessment structure plays an important part in controlling areas of study. Control of the exam. syllabus efectively controls the fields covered. The dominant attitude, that learning consists of being "taught", also makes courses boring. Very few courses allow time in Jecture periods for discussion of the topics raised. Students also have no say in deciding what they study.

I feel that the Union has an important role in improving this situation. A Union survey will shortly be carried out, looking at people's attitudes towards their courses. The findings should be formulated into Union policy and fought for on department staff/student committees, coordinated by the Union. Pressure must be put on departments to recognise the authority of Staff/student committees on questions of course content, structure and assessment. All these are important areas in making education democratic by giving students the right to participate in the directing of their education.

Closely related to this question is the vital campaign on grants and cuts. If we hope to improve standards of education we cannot allow the government to cut expenditure at a time when it needs extending. The argument that we must all share the brunt of the crisis is fallacious, not only in this sector but also in the rest of social services expenditure, while the government can afford to waste £3,000 million per annum on arms. The present discrepancies in the married women's grant and discretionary awards, along with parental contributions, illuminate the inequality of opportunity in education, and as such must be fought against.

Many people claim that Leeds University Union is undemocratic. True, decisions taken at OGMs only involve a fraction of the members. But if people are really interested they will turn up to hear and participate in discussions. If not, it is unreasonable for them to complain about the de-

As a Broad Left candidate and a Communist I think you should vote BROAD LEFT because, being an alliance of Labour, Communist and unaligned socialst students, it is the only group which can involve the mass of students on issues which concern them.

I don't wish, therefore to see any basic changes in the structure of these bodies but feel that much more can be done on a departmental level especially in relation to reelings on education and on course content, I would like to see more liason between the University, both on administrative and educative sides, and the Union.

The Union has a very important role to play in every students life, not only as a social club but on the general welfare of students and the furtherance of their opinions and beliefs on a national and even international scale. For this to be possible there must be a co-ordinating body for, firstly, the policies of students, and secondly the running of day to day life in the Union. Unfortunatly a crisis is occuring in the Union and unless something is done this is going to end up in the loss of the Union. The Union promises to sustain record losses this year. This is reflected also in declining use of the building due to its abysmal condition. It is essential to set up a working party which can review the situation and co-ordinate plans to attract back Union members.

Education Cuts! Education cuts are a fact!! They are aff ting education right from nurseries through to postgrad levels, and are painfully evident in the University with drastic cuts in services, staff and postgraduate opportunities etc. We must act now to try to reverse these cuts.

Many problems face the Union and the only way of solving them is by implementing active campaigns. The success of any campaign depends on participation thus leading to RELEVANT campaigns — the product of democratic debate.

I am standing as a Socialist but am not a member of any part. However, I feel that the Broad Left can best represent the interests of the majority of students and that in order for these Interests o be heard there must be active participation by as many students as possible. If elected I will obey all mandates and endeavour to further the objects of the Union.

The following are some of my views on issues related to Union Council:-FINANCES: U.C. must continue to make a careful review of all expenditure over the coming session. Societies and facilities used by the majority of students should not be the object of cuts. We must attempt to negotiate an increase in the per capita fee paid by L.E.A.s to the Union as this will be the only long-term solution to inflation. CAMPAIGNS, ETC .:

I believe we should be aiming at a grant which would increase in relation to a student cost of living index, (Threshold Agreement to the Tories and Sliding Scale to the Marxists!). This would make it unnecessary for the annual 'struggles' to increase the grant and would mean we could concentrate efforts in trying to get things like equal married women's grants and the abolishment of the parental contribution.

I dislike the way various political organisations use these campaigns to further their cause as I feel this puts off most of the people the campaign is supposed to involve. I do not belong to any political organisation and I am not bound by their policies.

UNION STRUCTURES:

We need a system in which the Union is more relevant to its members and whereby students can become interested in the running of the Union without it becomig a full-time occupation. Therefore, I favour:-*Departmentally-elected Union Council.

*Fewer O.G.M.s (once per fortnight) with a higher quorum, *Closed N.U.SPolicy Committee, elected by the normal election proceduce

I am a member of the International Marxist group (British Section of the Fourth International).

Next year will be crucial for the future of this Union and for our educational and living standards. The Union hasn't enough money to support itself, our grants fall in value as inflation increases and education cuts continue as the government tries to solve the present crisis at our expense. In sheer £ s d terms this must be obvious to even the most short-sighted student. So what are we going to do about it - how are we going to fight.

DIRECT ACTION - WINS! The grants campaign has been going on for 3 years and now includes the fight to defend education in general. And over those 3 years we have learned that certain tactics work while others do not. Most candidates for UC will probably agree on what we want — the difference is how we get them. Writing letters to MP's, dossiers on hardship cases, talking to the authories etc., DOES NOT WORK. 3 years of fighting has shown that the only way we will win is by taking direct action — as was shown at Oxford, Essex & Kent Universities.

We must fight for a single grant for all students as this will include every student and therefore give us the necessary unity from which to build. The figure of £845 was made 5 months ago and inflation is such that this figure needs to be £900 by todays prices.

However, given the extent of inflation, we need automatic increases in our grant every time prices rise. This is why the IMG has been calling for the sliding-scale of grants tied to a student cost of living index. Similarly we must demand the reversal of all cutbacks in education spending which have meant an increasingly inadequate education for fewer

A FIGHTING UNION - A POLITICAL UNION If we are to FIGHT against the attacks on our education then we must have a Union that can lead us — not one made up of careerists who want to do nothing, but a Union that IS thousands of students becoming involved in fighting for their education.

We must support other people who are fighting to defend their living standards eg. the Imperial typewriters workers who have occupied their factory to defend their jobs. If we are to become an EFFECTIVE Union, then we must recognise the importance of taking positions on fighting racism, Irelands struggle for national unity and women's liberation, If you read the manifesto of the other IMG candidates they will deal in more detail with those issues — I shall say why we think the EEC vote is crucial and why LUU should campaign for 'NO' vote.

EEC-NO, SOCIALIST EUROPE-YES The EEC was formed to strengthen European capitalism and Britains membership can only strengthen British capitalism at the expense of the vorking-class and student movement. However we of prices (Non-members who want to join the EEC have HIGHER rates of inflation than us) or because of "sovreignty" (capitalists are the same whether British or 'European') but because we want the overthrow of capitalism. The present problem of alienation from the Union must be solved. The whole of education is under serious attack from the present Government's policy on education cutbacks. Leeds University is not

The Cuts in Educational Spending

With the University at the moment running at a deficit of £100,000 per month and already having cut down on spending within the University, the representatives must be prepared to fight all future cuts affecting academic standards. Already demonstrators in Labs have been cut and tutorials have increased in numbers. My own tutorial started off the year with over 30 people present.

The University's policy of making cuts instead of pressurising the Government for more money will mean that when more money is available it will go to the Universities on the verge of bankruptcy, not the good boys who have saved their money and cut their standards.

The Inadequate Representation of Students on Senate and Associated Committees

With only 7 students on Senate elected separately without any common views means that Student views are completely drowned and rarely surface. Though I do not believe students should be mandatable by 150 people at an O.G.M., I do believe that students should have recourse if their representatives do not consider their views. To do this I believe students should be elected by the Union, and should resign if no confidenced by an O.G.M. and resubmit their nominations to another election.






