- We met with the Wake Up Foundation, a Bulgarian domestic abuse charity, to talk about Survivors' Forum and what it might involve to build a similar community for Bulgarian survivors.
- We hosted a testing session to make sure the new Live Chat set up (part of the move between digital agencies) is functioning effectively before we roll this out to survivors.
- **Recommendation**: as we move into the new year, one survivor shared that her aim for 2024 is to post on the Positive Moments board on Survivors' Forum. Any time you're having a hard day, the Positive Moments board can be a way to give yourself hope and remind yourself why we do this. We see survivors sharing updates of successfully separating joint bank accounts, starting counselling, being able to watch whatever movie they want now they've left, and so many more stories of healing.

External Affairs

- The Digital Team are continuing to action Love Respect edits ahead of user testing, scoping improvements for the Job Shop, overseeing Annual Audit production, working across the new Google Analytics platform and liaising with an agency on the 50th birthday logo design.
- The Public Affairs team is preparing for Committee Stage of the Victims and Prisoners Bill in the House of Lords, where amendments to the Bill are debated and voted on. The team is also continuing work on our general election campaign as we have entered the election year.
- Sophie is continuing to work with colleagues on the grant agreement for the 'Flexible Fund' (**still not for public sharing**) and is organising a visit for Safeguarding Minister Laura Farris MP to Ashiana, one of our by and for members.
